NAVOPACHE ELECTRIC COOPERATIVE, INC.'S CORRECTION OF INVENERGY WIND DEVELOPMENT, LLC'S MISTAKE OF FACT

Navopache Electric Cooperative, Inc. ("NEC" or "Cooperative"), by and through undersigned counsel, makes this filing to correct a fundamental factual mistake reflected in the Reply Invenergy Wind Development, LLC ("Invenergy") filed to Navopache's Opposition to Invenergy's Intervention. Tariff No. 12 for Sub-Transmission Service is not a part of the rate proceeding as it was expressly withdrawn by Navopache in its July 7, 2011 filing in this docket. As explained in Navopache's Opposition, issues associated with such service are complex and unduly broaden and complicate the present rate proceeding. To the extent otherwise allowed by law, and to the extent the parties cannot reach a mutually acceptable interconnection agreement, then the proper course for Invenergy would be to file a separate complaint proceeding.


