NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On July 1, 2011, Tucson Electric Power Company ("TEP" or Company") filed with the Arizona Corporation Commission ("Commission") its 2012 Renewable Energy Standard ("RES") Implementation Plan (the "Plan").

On August 2, 2011, SolarCity Corporation ("SolarCity") filed an application to intervene in the docket.

SolarCity designs, installs, maintains and finances residential and non-residential distributed solar generation facilities, and states that the outcome of this Docket will directly and substantially impact its ability to provide its services in Arizona.

No party objected to the requested intervention. SolarCity's activities in Arizona are directly and substantially affected by the subject matter of this docket and granting intervenor status will not delay or cause the issues of this proceeding to be unduly broadened..


