MOTION FOR SECURITY RELEASE

20 The Mount Tipton Water Company, Inc. ("Company"), hereby moves for a release  
21 of security. In Decision No. 70559, the Arizona Corporation Commission  
22 ("Commission") approved an emergency interim surcharge of \$10.00 per month per  
23 metered customer as requested by the Mount Tipton Water Company, Inc. ("Company").  
24 *Id.* at p. 20. The Commission required the Company to post a bond or letter of credit to  
25 serve as security until the permanent rate case was decided. *Id.* at p. 13-14. Pursuant to  
26 an amending decision, the Company deposited \$5,000 in a certificate as a security bond.  
27 *See* Decision No. 70838 at p. 3.

28 The Commission approved permanent rates for the Company in Decision No.  
72001 and the emergency surcharge was discontinued when the permanent rates took

1 effect. The surcharge funds have been spent on qualifying purchases and debt payments.  
2 Therefore, the Company requests that either (1) the Commission issue an order releasing  
3 the bond; (2) the Commission authorize Staff to issue a letter of release on behalf of the  
4 Commission.
