**BY THE COMMISSION:**

On July 1, 2011, Arizona Public Service Company ("APS" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for approval of its 2012 Renewable Energy Standard Implementation Plan and request for reset of renewable energy adjustor.

On August 2, 2011, SolarCity Corporation ("SolarCity") filed an Application for Leave to Intervene.

On August 10, 2011, Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan") and Arizonans for Electric Choice and Competition ("AECC") filed an Application for Intervention.

To date, no objections to the SolarCity, Freeport-McMoRan or AECC intervention requests have been received.

IT IS THEREFORE ORDERED that SolarCity, Freeport-McMoRan and AECC are hereby granted intervention.
