BY THE COMMISSION:

Pursuant to Decision No. 70658¹, Wilhoit Water Company, Inc. – Blue Hills #3 (“Wilhoit” or “Company”) filed a request with the Arizona Corporation Commission (“Commission”) for approval of an arsenic remediation surcharge². Wilhoit is an Arizona “C” corporation and a certificated Class E public service corporation that provides water service to approximately 56 customers in the town of Dewey in Yavapai County, Arizona.

Having considered the entire record herein and being fully advised in the premises, the Commission finds, concludes, and orders that:

FINDINGS OF FACT

1. The current rates were approved in Decision No. 70658, dated December 22, 2008.

² In Decision No. 70658, the term “arsenic removal surcharge” was used instead of “arsenic remediation surcharge.” This order uses the latter term hereafter.

1 2. Decision No. 70658 also authorized the Company to borrow up to \$70,000 from the
2 Arizona Water Infrastructure Finance Authority (“WIFA”), and ordered that the Company file an
3 arsenic remediation surcharge mechanism (“ARSM”) application for debt service of the WIFA
4 loan.

5 3. On October 26, 2010, pursuant to Decision No. 70658, Wilhoit filed with the
6 Commission a request for an arsenic remediation surcharge.

7 4. In the rate case, Staff recommended a methodology for determining the surcharge
8 amount once the Company knew the final loan amount and terms. Staff’s methodology involved:
9 1) finding the annual payment on the loan; 2) finding the annual interest payment amount; 3)
10 finding the annual principal payment amount; 4) finding the income taxes associated with the
11 revenues needed to make principal payments; 5) calculating the total annual surcharge revenue
12 requirement, which is the sum of the annual interest, principal payments, and income taxes; 6)
13 determining the equivalent bills based on the 5/8” meter size; and 6) determining the monthly
14 surcharge for each customer by dividing the annual surcharge revenue by the number of equivalent
15 customer bills.

16 5. Decision No. 70658 concluded that Staff’s recommendations were reasonable and
17 should be adopted.

18 6. Staff has replicated the methodology adopted by Decision No. 70658, to reflect the
19 most recent data. The resulting surcharge would be \$8.10 per month for the typical 5/8 x 3/4-inch
20 meter residential customer as indicated in attached Schedule DRE-1.

21 7. Staff concludes that implementation of an ARSM resulting in the surcharges listed
22 on Schedule DRE-1, is consistent with Decision No. 70658.

23 8. Staff recommends approval of the arsenic remediation surcharges as shown on
24 Schedule DRE-1.

25 9. Staff further recommends that the Company file a tariff explaining the terms and
26 conditions of the arsenic remediation surcharge within 30 days of the effective date of the Decision
27 resulting from this proceeding.

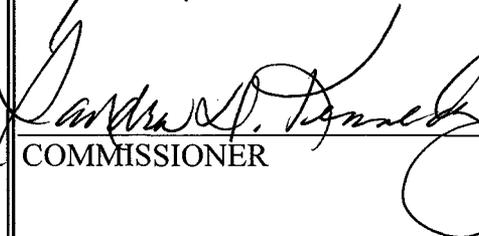
