ORDER GRANTING EXTENSION OF TIME ON REHEARING FOR FURTHER COMMISSION CONSIDERATION

BY THE COMMISSION:

On June 16, 2011, Cerbat Water Company filed an Application for Reconsideration of Decision No. 72385, requesting that the Commission reconsider and strike provisions in the decision that directed the Commission Staff to appoint an interim manager.

On June 24, 2011, the Commission granted rehearing of Decision No. 72385 for the limited purpose of affording additional time for further consideration.

At its August 16, 2011 Open Meeting, the Commission considered granting an extension of time for further consideration on rehearing, and heard comments from the parties on these matters. Upon due consideration of these matters, the Commission finds and concludes that it is appropriate to extend the period of time on rehearing for further consideration until otherwise ordered by the Commission.

Also upon due consideration, the Commission further finds and concludes that Cerbat Water Company should docket, on or before October 17, 2011, a status report concerning improvements in Company management and any issues related to its provision of safe and adequate water service to its

1 customers. The status report should include a description of all complaints received by the Company
2 from its customers and the manner and timeliness of the Company's response. Commission Staff is
3 directed to file its comments and recommendations concerning the Company's status report within 30
4 days of the Company's filing, and thereafter should bring this matter back before the Commission for
5 further discussion and consideration.

ORDER

8 IT IS THEREFORE ORDERED that the time period for rehearing of Decision No.72385 is
9 extended for the purpose of further consideration until otherwise ordered by the Commission.

10 IT IS FURTHER ORDERED that Cerbat Water Company shall file a status report in
11 compliance with this decision, and Staff shall file its comments and recommendations within 30 days
12 of the Company's filing.

13 IT IS FURTHER ORDERED that Decision No. 72385 shall remain in full force and effect
14 unless otherwise ordered by the Commission.

15 IT IS FURTHER ORDERED that this decision is effective immediately.






