


We are very concerned that our water bill will escalate out of our ability to purchase water. Over 7 years of history, our bill has risen from an average of \$30 per month to almost \$100 maximum with usage being relatively constant. If we have another increase, even as much as the most recent one, our bill will escalate to around \$175. If the Commission grants the 154% rate increase, our bill will exceed \$250. We have no landscaping, no trees, no farm animals, and no other water-hungry consumption problems. We are a family of four with an average usage of between 8000 and 12000 gallons per month. That is less than 100 gallons per person per day, which is well within the standards for human water usage.


We are also very concerned with the impact this rate increase will have on our property value. If a prospective buyer finds out the cost of water, it will surely drive the price down considerably.

Another question I have wanted to ask is *Why should I pay for a developer's problem? And Why should a rate increase, which will be forever, be required when a fixed capital expense is cited as the reason for the increase? The Capital expense will end sometime, but the rate increase will be forever!!!!*
