Respondent WEINER individually and doing business as RON WEINER ASSOCIATES ("RWA") consents to entry of this Order by the Commission.



IT IS HEREBY ORDERED that Decision No. 60956 shall be amended only as to the following: All payments currently held by the Attorney General's Office and all future restitution



