**PROCEDURAL ORDER**  
**CORRECTING CLERICAL ERROR**  
**IN DECISION NO. 72498**  
**NUNC PRO TUNC**

BY THE COMMISSION:

On July 25, 2011, the Arizona Corporation Commission ("Commission") issued Decision No. 72498, which granted a rate increase to Las Quintas Serenas Water Company.

On August 23, 2011, the Commission's Utilities Division Staff ("Staff") filed a Motion for Procedural Order *Nunc Pro Tunc* to Correct Typographical Error ("Motion"). In its Motion, Staff stated that on page 26, line 2, of Decision No. 72498 there is a typographical error in the Standpipe rate tier, stating "4,000 to 23,000 gallons." Staff notes that the gallon amounts should read "4,001 to 23,000 gallons."

Staff requests entry of an order *Nunc Pro Tunc* to correct Decision No. 72498 by deleting "4,000," and inserting "4,001."

Accordingly, the clerical error on found page 26, line 2 in Decision No. 72498, should be corrected *Nunc Pro Tunc*.
