(My emails for distribution are in block form and it is too time-consuming to weed out) For those of you who are not, please educate yourself on what smart meters are and register your complaints, preferably multiple times to different people and organizations. It is only through "strength in numbers" that we can effect change.

These meters are being installed right now all over the state. Below is Commissioner Burns' email to me. Quite apparently a lot of folks have complained and they are taking some kind of action. Burns appears to be level-headed and has done something. She is a conservative (R) - sidebar: when you vote please take the time to pay attention to all the elected offices that need to be filled, such as Commissioner, Judgeships, SRP Board, etc. Don't just guess or not vote.

SRP consumer relations - I spoke to Jane May. Her phone is

602-236-2196. She called me twice to let me know "they are working on it." Don't waste time calling the billing office. They will merely give you a spin that "people seem happy with it" (if so, it is probably 'cause they don't know any better) and "you can go on line to see how much energy you are using." I think you'll know that when you get the bill and most of us can wait until then. This is the response from Commissioner Burns Office. (This is what happens when just one citizen pursues a matter...just remember when all of us join in..)

Thank you for your e-mail regarding smart meters. Commissioner Burns has heard from many ratepayers about their concerns surrounding smart meters. She has contacted APS, TEP and SRP with questions she has a result of these issues being brought to her attention.

All of the commissioners have agreed to conduct a special hearing about smart meters. This meeting will occur in early September, most likely on Thursday September 8th at the commission's hearing room at 1200 W Washington Street in Phoenix. As soon as an agenda has been finalized, we will let you know.
