PROCEDURAL ORDER

BY THE COMMISSION:

On December 10, 2008, Bell Atlantic Communications, Inc. d/b/a Verizon Long Distance (“VLD”) filed an application with the Arizona Corporation Commission (“ACC”) to discontinue certain competitive resold telecommunications services in Arizona (“Application”).

On March 12, 2009, the Commission’s Utilities Division Staff (“Staff”) filed a Recommended Order for Commission consideration at Open Meeting. The matter was removed from the Open Meeting Agenda at VLD’s request.

On August 16, 2011, VLD filed a Withdrawal of Application requesting that the Commission close this matter, indicating that if VLD decides to pursue a similar application at a later time, it will file a new application containing updated information.

On August 26, 2011, Staff filed a memorandum stating that Staff does not object to VLD’s withdrawal of the Application.

IT IS THEREFORE ORDERED that Bell Atlantic Communications, Inc. d/b/a Verizon Long Distance’s request to withdraw its Application is granted.

IT IS FURTHER ORDERED that **Docket No. T-03289A-09-0583, In the Matter of the Application of Bell Atlantic Communications d/b/a/ Verizon Long Distance to Discontinue Certain Competitive Resold Telecommunications Services is administratively closed.**
