
On May 1, 2011, My Tel Co, Inc. ("MTC") filed voluntary petition for protection under Chapter 11 of the United States Bankruptcy Code in the Middle District of Florida, Case Number 6:11-bk-06496. Attached is a copy of the filing receipt for your records.

On July 14, 2011, the bankruptcy court approved an Asset Purchase Agreement between Birch Communications Inc. ("Birch") and MTC that provides for the sale of certain assets and customers of MTC located in seven (7) of the ten (10) jurisdictions where MTC is licensed to operate as a wireline telecommunications service provider.

MTC was issued a certificate of convenience and necessity to provide facilities based local exchange telecommunications and resold long distance service on August 6, 2009, in docket T-20486A-06-0709. In December 2009, MTC filed an application to cancel the local exchange portion of its license. At present, MTC currently holds certification for resold long distances services however, due to the aforementioned transaction MTC wishes to surrender it certificate. MTC has never had any customers in the State of Arizona so customer notice will not be required upon cancellation of the certificate.
