) INTORVENOR CLASSES

I, Sharon Wolcott, an intervenor representing myself wish to respond to Arizona-American's motion to include me in a intervenor class with other individuals.

My interests are not the same as the other intervenors in this case. I am a candidate for Mayor of Surprise and just finished first in the primary election. There will be a runoff election in November between myself and the incumbent.

As the City of Surprise is an intervenor, I will not be afforded the opportunity to participate in this case as other elected officials who so choose. If I am successful in November, I would be very involved in the City's approach to this case. In short, I believe the current posture of the city's involvement to be relatively narrow. If elected in November, I would expect there to be a policy shift in that regard. It is therefore crucial to remain active in this case in order to preserve a continuity of information which will guide the development of the appropriate public policy.

1 In summary, to allow for a consistent presentation of my views and approach
2 to this case so that any changes in the City's approach would have already
3 been made a part of the case through my intervention, I asked to be granted
4 the right to intervene as an individual.

5 If I fail to win the runoff, I would withdraw from the case.


