PROCEDURAL ORDER

BY THE COMMISSION:

On April 29, 2011, Mirabell Water Company ("Mirabell" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a permanent rate increase.

On May 31, 2011, the Commission's Utilities Division ("Staff") notified the Company that its application was sufficient and classified the Company as a Class D utility.

On August 16, 2011, Staff filed a Staff Report, recommending rates and charges different than those proposed by the Company.

On August 25, 2011, Mirabell filed a Response to the Staff Report in which it expressed concern with Staff's rate design and also provided additional and new information about accounts payable and proposed a temporary surcharge to pay down accounts payable. The additional information was not included in the original rate application, and is a substantial addition to the rate request that warrants suspension of the time clock pursuant to AAC R14-2-103.


IT IS THEREFORE ORDERED that Staff shall file a Reply to Mirabell's Response to the Staff Report by **October 3, 2011**.

IT IS FURTHER ORDERED that the **time clock** for a final order under AAC R14-2-103 is **suspended**.

IT IS FURTHER ORDERED that Staff or the Company shall make any **procedural recommendations** concerning whether a hearing is necessary or would be beneficial to the resolution of the issues raised in this matter by **October 3, 2011**.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
