PROCEDURAL ORDER

BY THE COMMISSION:

On February 6, 2009, the Arizona Corporation Commission ("Commission") issued Decision No. 70745 which granted an Order Preliminary to the issuance of an extension to the Certificate of Convenience and Necessity ("CC&N") for Keaton Development Company ("Keaton") for the provision of water service in portions of La Paz County, Arizona.

Pursuant to the Decision, Keaton was to file multiple compliance items within 3 years of the effective date of the Decision or the Order Preliminary would be deemed null and void.

On February 17, 2011, Keaton filed a letter stating that the owner/developer has no plans to proceed with the project and that the owner/developer is no longer requesting water service from Keaton. Keaton requested that the Order Preliminary be deemed null and void.

On July 18, 2011, the Commission's Utilities Division ("Staff") filed a memorandum stating that it has no objections to Keaton's request that the Order Preliminary be deemed null and void. Staff further recommended that this docket be administratively closed.

Accordingly, the above-captioned docket should be administratively closed.


