**BY THE COMMISSION:**

On September 9, 2011, the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") filed a Supplemental Staff Report in this matter. Staff is recommending approval of Sonoita Valley Water Company's revised spending plan and request for authority to borrow from the Water Infrastructure Financing Authority ("WIFA") with conditions and the implementation of surcharge to pay the WIFA debt.

The Supplement Staff Report does not indicate that it was mailed to the intervenor in this matter. Consequently, with this Procedural Order, a copy of the Supplemental Staff Report is being sent to Ms. Joy Vargo.


