**MOTION FOR EXTENSION OF TIME**

TUCSON ELECTRIC POWER COMPANY )

On September 13, 2011, Tyrone Henry filed a complaint against Tucson Electric Power Company ("TEP") with the Arizona Corporation Commission in the above-captioned matter.<sup>1</sup> Pursuant to A.A.C. R14-3-206.H, TEP is required to file its answer to the complaint.

Since the filing of the complaint, TEP and Mr. Henry have engaged in settlement discussions and the parties are in the process of determining whether a settlement can be reached. Although TEP was hoping that this determination could have been made prior to the deadline to file its answer, additional time is needed to complete settlement discussions which could render the need to file an answer moot.

Accordingly, TEP requests an extension of time to file its answer. TEP hereby proposes that if a settlement is reached, TEP will file a Motion to Dismiss the complaint as soon as practicable after execution of a settlement agreement by the parties. If a settlement is not reached, TEP will file its answer to the complaint within 20 days of a determination that a settlement will not be possible. Good cause exists to grant this request.


