BY THE COMMISSION:

On July 1, 2011, Tucson Electric Power Company ("TEP" or Company) filed with the Arizona Corporation Commission ("Commission") its 2012 Renewable Energy Standard Implementation Plan and request for reset of renewable energy adjustor.

Intervention has been granted to the Solar Alliance ("Solar Alliance"), SolarCity Corporation ("SolarCity"), Freeport-McMoRan Copper & Gold, Inc. ("Freeport-McMoRan") and Arizonans for Choice and Competition ("AECC"), Western Resource Advocates ("WRA"), Arizona Solar Energy Industries Association ("AriSEIA") and the Residential Utility Consumer Office ("RUCO").

On October 19, 2011, Kevin M. Koch filed a Motion to Intervene.


No party has objected to the requested intervention.


