

PROCEDURAL ORDER

BY THE COMMISSION:

On June 1, 2011, Picacho Peak Water Company ("Picacho" or "Company") filed with the Commission an application for a permanent rate increase ("Application").

On August 17, 2011, the Commission's Utilities Division ("Staff") issued its Sufficiency Letter indicating that Picacho's Application was sufficient under the Arizona Administrative Code.

On October 14, 2011, the parties filed a Joint Stipulation to Suspend Time Clock and Request for Procedural Order ("Motion"), noting that Staff recently became aware that Picacho is in discussions with the Arizona Department of Environmental Quality ("ADEQ") about compliance issues. Staff believes that these compliance issues need to be resolved before Staff may evaluate the Application.

Staff states that Staff has discussed this issue with Picacho and the parties stipulated to a suspension of the time clock and procedural deadlines while Picacho and ADEQ work to resolve the Company's compliance issues. The parties request that a procedural order be issued indefinitely suspending the time clock and all filing deadlines until all compliance issues have been resolved.

IT IS THEREFORE ORDERED that the Motion is granted and the **time clock and filing deadlines in this matter are suspended.**

IT IS FURTHER ORDERED that Picacho Peak Water Company shall **file with Docket Control a Status Report regarding the Company's compliance with ADEQ regulations every 60 days, with the first Status Report due no later than December 23, 2011.**
