PROCEDURAL ORDER

BY THE COMMISSION:

On February 25, 2011, Elfrida Domestic Water Users Association ("Elfrida") filed with the Arizona Corporation Commission ("Commission") an application for approval to sell its assets and to cancel its Certificate of Convenience and Necessity for provision of water service ("Application").

On September 6, 2011, the Commission's Utilities Division ("Staff") filed Sufficiency Letter stating that Elfrida's Application is sufficient under the Arizona Administrative Code.

IT IS THEREFORE ORDERED that a telephonic Procedural Conference shall commence on November 30, 2011, at 2:00 p.m., and that the parties shall contact the Hearing Division on November 22, 2011, at 602-542-4250 for further information regarding the call-in phone number. Parties may also attend in person at the Commission's Tucson offices, 400 West Congress Street, Room 218, Tucson, Arizona 85701.

IT IS FURTHER ORDERED that the parties shall be prepared at the Procedural Conference to discuss the necessity of a hearing.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized Communications) applies to this proceeding as the matter is now set for public hearing.


