

- (2) Defendant shall not commit any criminal offense; shall obey all orders of the Court, shall promptly notify the Court of any change of address, shall not leave the State of Arizona without written permission of the Court, and shall stay in contact with your attorney, if one is retained. If applicable, diligently prosecute appeal following judgment and sentence;
- (3) Defendant shall not possess or consume any alcoholic beverage, illegal drug, or drug paraphernalia;
- (4) Defendant shall not possess any firearm or other deadly weapon;
- (5) Defendant shall not contact **IN ANY MANNER** the alleged victim(s), Norm Rask, Timothy Hardy, Douglas Slover, Sr., Michael Rippa, Douglas Slover, Jr., Patricia Olsen, and shall not go near Victim(s)' Residence Victim(s)' Place of employment Other _____; Defendant may make one trip to the victim(s)' residence to obtain Defendant's personal property if accompanied by a law enforcement officer.
