PROCEDURAL ORDER

BY THE COMMISSION:

On February 22, 2011, Orange Grove Water Company, Inc. ("Orange Grove" or "Company") filed with the Arizona Corporation Commission ("Commission") an Application for Approval of Financing in Docket No. W-02237A-11-0084.

On April 27, 2011, OGWC filed with the Commission an Application for Approval of a Rate Increase in Docket No. W-02237A-11-0180.

On May 20, 2011, Staff issued a Notice of Sufficiency indicating that the Company's rate application was sufficient, and classifying the Company as a Class D utility.

On June 10, 2011, Staff filed a Motion to Consolidate the rate application and the financing application.

On June 15, 2011, a Procedural Order was issued consolidating the rate application and financing application dockets.

On July 25, 2011, the Company filed an Affidavit indicating the provision of public notice of the financing application.

On August 9, 2011, after conducting an investigation of Orange Grove's proposed rates and charges for water service and the financing request, the Commission's Utilities Division ("Staff") filed its Staff Report in the consolidated dockets. The Staff Report indicated that any party wishing to file comments to the Staff Report should file them with the Commission's Docket Control by 4:00

1 p.m. on or before August 19, 2011.

2 On August 19, 2011, Orange Grove filed its Comments to the Staff Report.

3 On August 24, 2011, a Procedural Order was issued directing Staff to file a Response to the
4 Comments, and directing that the Response include any updated schedules, if applicable.


5 On September 16, 2011, Staff filed a Response to Orange Grove's Comments ("Response"),
6 and a Revised Staff Report.

7 On September 27, 2011, Orange Grove filed a Reply to Staff's Response ("Reply").

8 The time period prescribed by Arizona Administrative Code R14-2-103(B)(11)(d) should be
9 extended to allow sufficient time for the review of Orange Grove's Reply.

10 IT IS THEREFORE ORDERED that the time period prescribed by Arizona Administrative
11 Code R14-2-103(B)(11)(d) is hereby extended for 30 days in order to allow sufficient time for the
12 review of Orange Grove Water Company, Inc.'s Reply.
