PROCEDURAL ORDER

14 BY THE COMMISSION:

15 On September 15, 1998, the Arizona Corporation Commission ("Commission") issued
16 Decision No. 61120 in the above-captioned matter. As part of the Decision, the Commission
17 ordered that a hearing be scheduled regarding the proposed rulemaking. Pursuant to those
18 directions, the following hearing date is hereby established.

19 IT IS THEREFORE ORDERED that a public comment hearing on the above-captioned matter
20 shall be held on November 10, 1998 at 1:00 p.m. or as soon thereafter as is practical, at the
21 Commission's office, 1200 West Washington Street, Phoenix, Arizona.

22 IT IS FURTHER ORDERED that the Utilities Division shall provide timely notice of the
23 proposed rulemaking in the Arizona Administrative Register.

24 IT IS FURTHER ORDERED that the Utilities Division shall publish notice of the proposed
25 rulemaking in an Arizona business newspaper of statewide circulation no later than October 5, 1998
26 and shall provide the notice to at least one industry organization/association for each type of public
27 service corporation (water, wastewater, electric, gas, telecommunications).


28 IT IS FURTHER ORDERED that, although comments in this matter will be taken through


