PROCEDURAL ORDER

BY THE COMMISSION:

On April 27, 2000, Allied Riser of Arizona, Inc. ("Applicant") filed with Docket Control of the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold and facilities-based local exchange and interexchange telecommunications services in the State of Arizona.

The Commission's Utilities Division Staff ("Staff") filed a Staff Report on August 18, 2000.

The Applicant is required to publish notice of its filing in newspapers in all counties where service is to be provided. The record shows that the Applicant has published notice with affidavits of publication filed with the Commission on June 16, 2000.


On August 23, 2000, a Procedural Order was issued scheduling a hearing on the matter for October 4, 2000 at 2:00 p.m.

The scheduled hearing date conflicts with the Commission's rescheduled Open Meeting date. The Applicant and Staff did not oppose rescheduling the hearing date in this matter.


