MOTION TO AMEND ORDER

Pursuant to Ariz. Rev. Stat. § 40-252, Allied Riser of Arizona, Inc. (the "Company"), respectfully requests that the Commission amend the order entered in this Docket on November 16, 2000 (the "Order") as set forth below. In support of its request, the Company states:

1. On or about April 26, 2000, the Company filed its application for a certificate of convenience and necessity to provide certain telecommunications services (the "Application").
2. On August 18, 2000, the Commission's Utilities Division Staff

to state that the Staff does not object to the granting of the relief requested herein.

WHEREFORE, the Company respectfully requests that the Order be amended as follows:

1. The Company respectfully requests that paragraph 9 of the Commission's Conclusions of Law on page 5 of the Order be replaced in its entirety with the following language: "Staff's recommendations in Findings of Fact Nos. 12, 13, and 17 are reasonable and should be adopted, with the exception of the timing of Applicant's filing of its plan to publish and include its customers' telephone numbers in incumbents' directories and directory assistance databases, its tariff filing, and its FVRB filing."

2. The Company respectfully requests that an ordering paragraph be added to the Order stating, "IT IS FURTHER ORDERED that Allied Riser of Arizona, Inc. shall file its plan to have its customers' telephone numbers included in the incumbents' directories and directory assistance databases at least 30 days prior to the provision of service."
