PROCEDURAL ORDER

BY THE COMMISSION:

16 On November 16, 2000, the Arizona Corporation Commission ("Commission") issued
17 Decision No. 63147 which granted Allied Riser of Arizona, Inc. ("Allied") a certificate of
18 convenience and necessity ("CC&N") to provide intrastate telecommunications services as a
19 facilities-based provider and reseller and petition for competitive classification of proposed services
20 within the State of the Arizona.

21 Pursuant to Decision No. 63147, Allied was ordered to file its plan regarding publication and
22 inclusion of its customers' telephone numbers in incumbents' directories and directory assistance
23 databases within 30 days of the date of the Decision.

24 On February 9, 2001, Allied filed a Motion to Amend Order ("Motion"). In its Motion,
25 Allied requested it be granted an extension to file its plan to publish and include customers' telephone
26 numbers in incumbents' directories and directory assistance databases. Allied requests that its plan to
27 have its customers' telephone numbers included in the incumbents' directories and directory
28 assistance databases be filed at least 30 days prior to the provision of service.

Staff has no objections to the Motion.

1 IT IS THEREFORE ORDERED that Allied's request to extend the filing date for its plan to
2 have its customers' telephone numbers included in the incumbents' directories and directory
3 assistance databases at least 30 days prior to the provision of service, is hereby granted.


