**MOTION TO EXTEND FILING
DEADLINES**

1 Chino Meadows II Water Co., Inc., ("Chino Meadows") hereby moves to extend the
2 deadlines for filing initial briefs to December 2, 2011, and for filing reply briefs to December 16,
3 2011.

4 The reason for this request is that the Commission previously approved extending the
5 deadline for Commission Staff to file its final schedules from October 19, 2011, to November 9,
6 2011. Staff did not file the schedules by the deadline. These schedules are needed for Chino
7 Meadows to draft its brief. There is simply not enough time remaining for Chino Meadows to
8 review the schedules and complete its brief by the present deadline of November 18, 2011.

9 Counsel for Chino Meadows has discussed its request with Staff Counsel Charles Hains
10 and is authorized to state that Staff does not oppose the requested deadline extensions.

11 Chino Meadows agrees to further waive the Commission's time-clock rule [A.A.C. R14-
12 2-103(B)(11)] as necessary to allow a Recommended Opinion and Order in this matter to be
13 considered at the Commission's regularly scheduled Open Meeting of February 14 and 15, 2012.


