("Trico") filed for approval of its 2012 Renewable Energy Standard Tariff Implementation Plan (the "Implementation Plan") with the Arizona Corporation Commission (the "ACC") in Docket No. E-01461A-11-0266 (the "Docket"). SolarCity Corporation ("SolarCity"), by and through its undersigned counsel and pursuant to R14-3-105, hereby respectfully requests that the ACC issue an Order granting it leave to intervene in the Docket. In support of this Motion SolarCity states the following:


