I, the undersigned, do hereby petition the Arizona Corporation Commission to approve the deconsolidation of the Anthem/Agua Fria Wastewater District for the following reasons:

1. In Decision 72047, the commission rejected statewide AND partial consolidation of any of Arizona-American Water Company's (AAWC) water and wastewater districts..
2. The Commission is on record stating tht utility customers should pay for the "cost of service" that is incurred by the provider of that service.
3. Under the current AAWC rate structure, customers of the Anthem portion of the consolidated Anthem/Agua Fria Wastewater District are the ONLY customers in the entire AAWC system who are paying MORE than the "cost of service" and are subsidizing customers of other wastewater systems.
4. Anthem has offered a 3-0year revenue-neutral transition plan that mitigates the rate shock to Agua Fria district customers.

Deconsolidation of the Anthem/Agua Fria Wastewater District will result in the consistent treatment of all customers within the Arizona-American-Water Company's systems.
