Dear Members of the Arizona Corporation Commission,

As you are aware, **Physicians for Social Responsibility in Arizona** is the medical and public health voice working to stop degradation of the environment in our state.

On behalf of our members across the state, particularly those that are Arizona Public Service (APS) and/or Southwest Gas (SW Gas) customers, I am writing to urge you include a strong policy on decoupling in those rate cases.

I know you are aware that utilities have an incentive to encourage the use of more energy, as that enables their profits to increase. This system really isn't beneficial to the utilities who end up investing in costly capital expenditures and it certainly isn't beneficial to the health of Arizonans who end up breathing more polluted air, which is linked to respiratory illnesses.

The burning of coal, oil, and natural gas produces not only greenhouse gases, but also a range of harmful air pollutants, including ozone, airborne particulates, sulfur dioxide, and nitrogen oxides. Exposure to these pollutants causes a number of adverse health effects ranging from shortness of breath and coughing to lung cancer and premature death. As emissions of greenhouse gases continue to rise, so too will emissions of these harmful air pollutants. Increasing temperatures will further worsen air quality problems across the United States. Hotter temperatures will speed the formation of ground-level ozone, the main component of smog. Smog exposure damages the lungs and can lead to the development and aggravation of chronic lung diseases, such as asthma. Higher temperatures, combined with elevated carbon dioxide levels, may also increase the concentration of natural air pollutants, such as pollen, which will exacerbate the symptoms of people with allergies. Additionally, as people struggle to adapt to warmer temperatures, increased energy use to power air conditioners on hot days would put even greater amounts of pollutants into the air.

Therefore, I urge you include a strong policy on decoupling in those rate cases and to further encourage strong measure to increase energy efficiency among energy users throughout Arizona. Thank you.
