JOINT REVISED PROCEDURAL SCHEDULE

Mohave Electric Cooperative, Incorporated ("Mohave" or the "Cooperative") and Commission Utilities Division Staff ("Staff"), by and through undersigned counsel, hereby submits a joint revised procedural schedule. Both parties contend their respective positions relating to the Staff's request for an extension has merit. However, in the spirit of compromise and in an effort to avoid prolonged disputes, and based upon the limited availability of hearing dates following the currently scheduled hearing, the parties mutually support the revised procedural schedule set forth below and an extension of the time clock to accommodate the revised schedule, as well as a 24 day extension of the time clock for post hearing deadlines to reflect the delay in the start of the hearing.

The parties agree that the hearing may begin as early as 4/9/2012, which would require the pre-hearing conference to be held during the week of 4/2/2012 subject to the availability of the hearing division. The proposed schedule is as follows:


