Finally, the Commission may also have to review the rates established as a result of the FCC's recent decision in its Local Competition Third Report and Order.<sup>2</sup>

The Commission Staff recommends that a procedural conference be held and that all parties be given an opportunity to indicate what, if any, other issues should be reviewed in this proceeding

WHEREFORE, the Commission Staff respectfully requests that the Commission reopen the Consolidated Cost Docket or open a new sub-Docket of the Consolidated Cost Docket to examine the issues raised herein.
