PROCEDURAL ORDER

BY THE COMMISSION:

On October 29, 1996, the Arizona Corporation Commission ("Commission") issued Decision No. 59873 in this docket. In that Decision, the Commission ordered TCG Phoenix and U S WEST Communications, Inc. ("U S WEST") to submit an interconnection agreement incorporating the terms of the Commission's resolutions of issues in Decision No. 59873 within 30 days.

On November 29, 1996, the parties submitted an interconnection agreement. On the same date, U S WEST filed a Reservation of Rights Regarding Filing of Interconnection Agreement. On December 6, 1996, the parties filed a substituted interconnection agreement. Neither of the interconnection agreements filed by the parties was signed by the parties.

IT IS THEREFORE ORDERED that the TCG Phoenix and U S WEST Communications, Inc. shall file a signed interconnection agreement complying with the terms of Decision 59873 no later than December 13, 1996.


