**RESPONSE TO PROCEDURAL ORDER**

In response to the Procedural Order dated April 2, 2012, IntelPeer, Inc.

16 (“IntelPeer”) provides the following status update. As noted in its letter dated November  
 17 4, 2011, IntelPeer intends to undertake one or more *pro forma* intra-corporate  
 18 transactions, none of which will impact the ultimate ownership of IntelPeer or its day-to  
 19 day operations. To date, IntelPeer has not consummated those transactions, but still  
 20 intends to do so in the near future.<sup>1</sup>

22 As noted in its November 4, 2011 letter, IntelPeer will provide the details of any  
 23 such *pro forma* transactions once they are available. However, given that these  
 24 transactions will not affect the ultimate ownership of IntelPeer or its day-to-day  
 25

1 operations, IntelPeer strongly believes that, for all of the reasons stated in the  
2 Recommended Opinion and Order, it continues to be in the public interest to grant  
3 IntelPeer a Certificate of Convenience and Necessity. Accordingly, IntelPeer  
4 respectfully requests that the Recommended Opinion and Order be placed on the agenda  
5 for the June 19-20, 2012 Open Meeting.
