BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Arnold H. and Beverly J. Polzin d/b/a A & B Payphone Systems ("Applicant") has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in Arizona pursuant to Decision No. 60400 (September 26, 1997).

2. On October 24, 2011, the Applicant filed with the Commission an application for cancellation of the Certificate ("Application").

3. On November 16, 2011, the Commission's Utilities Division Staff ("Staff") filed a Staff Report, recommending approval of the Application and cancellation of the Applicant's Certificate without a hearing.

4. According to the Application, the Applicant's Vice President of Operations, Arnold Polzin, is the person authorized to file the Application. Mr. Polzin indicated that the Applicant no longer provides COPT service in Arizona and requests cancellation of its Certificate without a hearing.

ORDER

IT IS THEREFORE ORDERED that the Application of Arnold H. and Beverly J. Polzin d/b/a A & B Payphone Systems for the cancellation of its Certificate of Convenience and Necessity to provide customer-owned pay telephone service in Arizona is approved and the Certificate of Convenience and Necessity granted in Decision No. 60400 is cancelled.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.


