**BY THE COMMISSION:**

On October 13, 2011, Transworld Network Corp. ("TNC") filed with the Arizona Corporation Commission ("Commission") a petition for designation as an eligible telecommunications carrier pursuant to Section 214(e)(2) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(e)(2).

On December 5, 2011, Valley Telephone Cooperative, Inc. ("VTC") and Copper Valley Telephone, Inc. ("Copper Valley") filed a Joint Application for Leave to intervene.

No objections have been filed to VTC and Copper Valley's request for intervention.

IT IS THEREFORE ORDERED that the VTC and Copper Valley are hereby granted intervention.
