Pursuant to Arizona Corporation Commission (Commission) Decision No. 72215, Arizona Public Service Company (APS or the Company) is required to file:


IT IS FURTHER ORDERED that Arizona Public Service Company shall file, in Docket Control under Docket No. E-01345A-10-0075, an evaluation report for the HEI pilot program by December 31, 2011. This report shall provide a mid-point assessment of information gathered on the program. *Decision No. 72215, page 19, lines 1-4.*

As noted by APS in its Request for Revision to Schedule, filed in this docket on November 4, 2011, the HEI Pilot was designed to be conducted during two successive summer seasons. Because approval occurred later than anticipated, the Company was unable to implement the HEI Pilot by summer 2011. Therefore, no information has been gathered to date and the Company cannot file a mid-point assessment by December 31, 2011. APS is currently implementing the HEI Pilot and will report on its progress as proposed (both in DSM semi-annual filings and a mid-point assessment on December 31, 2012).

Although APS's Request for Revision has not yet been approved by the Commission, Staff has recommended granting the Company's request in its transmittal memorandum and proposed order dated November 30, 2011 in Docket No. E-01345A-11-0232.
