**MOHAVE ELECTRIC
COOPERATIVE'S COMMENTS IN
SUPPORT OF PROPOSED ORDER**

Mohave Electric Cooperative, Incorporated ("MEC"), through its undersigned attorneys, submits these comments in support of the proposed Order filed by Commission Staff ("Staff") on December 9, 2011. MEC appreciates Staff's thorough review and recommendations. While not requesting any amendments to the proposed Order, MEC does note that commencing on November 28, 2011, it was necessary to establish a waiting list for its Sun Watts Residential and Commercial Incentives and that as of December 23, 2011, nine (9) residential customers and zero (0) commercial customers have been placed on the waiting list. This nominal waiting list has not caused MEC to recommend a change in its incentive levels, but MEC has submitted a request to Staff in accordance with its proposed 2012 REST Plan to move \$139,500 in funding from budgets, with unused carry over to cover this shortfall. MEC provides this additional information simply to clarify the current facts, which are slightly different than set forth in Finding of Fact No. 10 of the proposed Order.¹

¹ Finding of Fact #10 on page 3 of the proposed Order states: "Since there is no backlog of incentive requests, MEC has not proposed any change to incentive amounts."
