PROCEDURAL ORDER

BY THE COMMISSION:

On November 22, 2011, Litchfield Park Service Company ("LPSCO" or the "Company") filed Applications for both its water and wastewater operations for a waiver of the Affiliated Interests Rules concerning the sale of the stock of Entrada Del Oro Sewer Company to LPSCO's parent, Liberty Water Company.

On December 22, 2011, LPSCO filed Motions in both dockets to consolidate the above-captioned Dockets. LPSCO states that Liberty Water operates LPSCO's water and wastewater systems as one utility, and that the facts giving rise to the applications and the legal issues are identical.

The matters are substantially the same, and the rights of the parties will not be prejudiced by consolidation. The interests of judicial efficiency and administrative economy warrant consolidation.

IT IS THEREFORE ORDERED that **Docket Nos. W-01427A-11-0419 and SW-01428A-11-0420 are consolidated.**




