By Procedural Order dated June 2, 2011, the deadlines for filing written testimony in this matter were established.

On January 12, 2011, the Residential Utility Consumer Office ("RUCO"), on behalf of all the parties to this docket, filed a Motion to Continue Deadlines for Surrebuttal and Rejoinder Testimony. RUCO states that because the parties are attempting to resolve one or more major issues in this matter, but face resource and time constraints, the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") and RUCO require more time to file Surrebuttal testimony.
