PROCEDURAL ORDER

BY THE COMMISSION:

On July 3, 2007, Telrite Corporation (“Telrite” or “Company”) filed with the Arizona Corporation Commission (“Commission”) an application for a Certificate of Convenience and Necessity (“CC&N”) to provide telecommunications services in the State of Arizona.

On August 14, 2009, by Procedural Order, the Commission’s Utilities Division (“Staff”) was directed to file an update on the status of Telrite’s application.

On September 18, 2009, Staff filed an update and requested that this docket remain open.

On January 18, 2012, Telrite filed a letter requesting to withdraw its application in this docket. Telrite’s letter states that the anticipated services supporting the Company’s application have not come to fruition and that continuance of this matter is no longer necessary.

On February 2, 2012, Staff filed a memorandum in response to Telrite’s request to withdraw its application. Staff stated that it has not received any response to its August 15, 2007, Letter of Insufficiency and First Set of Data Requests. Therefore, Staff recommended that Telrite’s request to withdraw its application be granted and that this docket be administratively closed.


Accordingly, Telrite’s request to withdraw its application should be granted, and this docket should be administratively closed.
