Navopache Electric Cooperative, Inc. ("Navopache"), by and through its counsel undersigned, makes this compliance filing pursuant to Commission Decision No. 71859, as amended by Decision No. 72010. Navopache has now completed construction of the oil containment structure for its transformer within the Coronado Generation Station as ordered by the Decision. Navopache thanks the Commission for its patience and apologizes for not completing construction by December 31, 2011.<sup>1</sup> Navopache believes its request for an extension pursuant to A.R.S. § 40-252 filed December 30, 2011 is now moot.

Navopache further understands that this compliance filing constitutes the final compliance filing required by Decision No. 71859, as amended by Decision No. 72010.

<sup>1</sup> Navopache notes that at all times an earthen berm, like that utilized by SRP at this site, has existed and acts to contain any oil that might spill from its transformer.
