PROCEDURAL ORDER

**BY THE COMMISSION:**

In a Procedural Order dated December 19, 2012, hearings in this matter were set to commence on January 26, 2012, and on February 29, 2012. Subsequent to the January 26, 2012, hearing, on February 17, 2012, Vail Water Company ("VWC" or "Company") and the Arizona Corporation Commission's ("Commission") Utilities Division ("Staff") participated in a telephonic Procedural Order, and requested that the February 29, 2012, hearing be continued approximately 30 days to provide time for Staff to evaluate a proposal by the Company that may resolve some or all of the issues to be considered at that hearing.

Given that the request as made by both parties, no party's rights will be prejudiced by the relatively short continuance.


IT IS THEREFORE ORDERED that the February 29, 2012, hearing date is vacated and the hearing is re-set to commence on March 29, 2012, at 10:00 a.m. or as soon thereafter as is practical, at the Commission's Tucson offices, Room 222, 400 West Congress St., Tucson, Arizona 85701.

2 **Testimony and associated exhibits is extended until March 22, 2012.**

3 IT IS FURTHER ORDERED that because the matter has been noticed to ratepayers, the  
4 **Commission will convene a public comment meeting on the original February 29, 2012 hearing**  
5 **date, at 10:00 a.m.**

6 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,  
7 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
8 hearing.


