

This Surrebuttal Testimony in this proceeding addresses a number of clarification issues which Semstream Arizona Propane addressed in its Rebuttal Testimony.

1 **INTRODUCTION**

2 **Q. Please state your name, occupation, and business address.**

3 A. My name is Robert G. Gray. I am an Executive Consultant III employed by the Arizona
4 Corporation Commission ("ACC" or "Commission") in the Utilities Division ("Staff").
5 My business address is 1200 West Washington Street, Phoenix, Arizona 85007.

7 **Q. Are you the same Robert G. Gray that filed Direct Testimony in this case on behalf
8 of Staff?**

9 A. Yes.

11 **Q. What is the scope of this testimony?**

12 A. Semstream Arizona Propane's ("Semstream Arizona" or "Company") Rebuttal Testimony
13 generally accepted the positions contained in Staff's Direct Testimony, but had a handful
14 of areas where minor clarifications and adjustments were made. This testimony provides
15 Staff's response to Semstream's Rebuttal Testimony.

17 **Q. Please identify the matters contained in Semstream's Rebuttal Testimony to which
18 Staff is responding.**

19 A. This testimony responds to the following matters:

21 1. Elimination of proposed after hours customer charges establishment of service and
22 reconnection of service, in concert with inclusion of a \$55.00 per hour after hours
23 service labor charge.
24 2. Clarification of tariff language indicating that the cost of gas is collected solely
25 through the purchased gas adjustor.

1 3. Clarification of tariff language in Section 4(f) of the Rules and Regulations
2 regarding miscellaneous services provided by the Company.

3 4. Correction of an erroneous per foot number in Section 7(c) of the Rules and
4 Regulations regarding the charge per foot for service line extensions.

5

6 **Q. Does Staff agree with these corrections put forth by Semstream in its Rebuttal**
7 **Testimony?**

8 A. Yes.

10 **Q. Is Staff aware of any outstanding disputed issues in this proceeding?**
