SUMMARY OF THE TESTIMONY OF WILLIAM M. GARFIELD
ON BEHALF OF ARIZONA WATER COMPANY

Mr. Garfield is President of Arizona Water Company. He participated in all of the settlement discussions that led to the February 15, 2012 Settlement Agreement in this matter. He will testify concerning the events that led up to the adoption of the Settlement Agreement in this matter, including the results sought by the Company in its amended application and the resolution of the issues by settlement. He will testify that the Settlement Agreement is a fair and reasonable solution of this contested rate proceeding, and will summarize the terms of the settlement. He will testify that a key settlement consideration for Arizona Water Company was promptly resolving the issues presented in order to implement new rates at the earliest possible time. Mr. Garfield will also testify that the settlement provides rates that are just and reasonable, promotes water conservation, establishes a rate design that provides residential ratepayers with the ability to manage utility costs through reductions in usage, and provides Arizona Water Company with operating revenues to maintain safe, reliable and adequate utility service to its customers. He will further testify that the settlement process was open, inclusive, and provided all parties with the opportunity to voice concerns and work together to achieve mutually beneficial results.

Mr. Garfield recommends that the Commission adopt the Settlement Agreement entered into by all parties in this rate proceeding.
