Rebuttal testimony and associated exhibits on behalf of CenturyLink, or by Staff or intervenors to testimony other than that of CenturyLink - April 16, 2012.

The revised filing dates will allow the Staff and intervenors more time to consider the matters addressed by the Application, preserve for all participants the same amount of time to prepare rebuttal testimony as the initial procedural schedule allowed, and do not delay the hearing date.


1 Counsel for the parties whose intervention has been granted have been advised of this
