Dear Commissioners: I am a resident of Sun Lakes at 26409 S. Ribbonwood Drive and have been a resident and customer of Pima Utility since 1989. In reviewing the information Pima Utility has submitted for a possible rate increase, I question the quality of their infrastructure which has to be a huge burden on their operating expenses. It is believed by many in this community that when our water system was originally installed that Pima used the absolutely cheapest products and installation possible. Today, we see them all over the community digging up the streets, driveways, yards to replace faulty pipes that many believe is because of their initial installation.

A rate increase ?? Probably a rate increase is justified. Please, just keep in mind that the smarmy letter they sent to each Homeowner tells only a small part of the story -- that of the residential increase.

the residential increase. Each Homeowner is also going to be burdened with an even greater increase for the irrigation water used in our common areas and golf courses. Based on what water tests have been made in the past, even some of the irrigation water has such a high level of sodium that it makes it extremely difficult to grow grass without extra expense for chemicals to counter the sodium. Not once in their letter to the Homeowners do they mention that the amount each person will pay for irrigation water through their Homeowner Association Dues will in fact be more than the increase for the residential request!!!

In your review of this request, please take into consideration the perceived faulty installation of their infrastructure, the less than suitable sodium content and what is believed to be an abnormally high requested rate increase. Thank you for your attention to this matter.


I see the rising costs of companies and think a four or five percent rate increase would be justified.

Dear Mr. Pierce:

My wife and I want to express our concern over the proposed rate increase by Pima Utility Co. We have been full time residents in Sun Lakes Cottonwood area, and a customer of Pima Utility Co., since 1994 and have watched costs steadily increase. We fully understand the need to increase dues and fecs periodically for goods and services to keep up with material and labors costs. However, what is being proposed is a pretty hefty increase in anyone's books. Granted, the monthly increase will be between \$8.00 and \$10.00 per household. This translates into an increase yearly of between \$96.00 and \$120.00. Even though there are many households here that can afford this, there are a considerable number of elderly residents living on a fixed (and sometimes very minimal) income who find it already difficult to cope with the steadily increasing costs of living. We personally have heard this sentiment expressed before, that medical science is a wonderful thing. It allows us to live much longer now; each year at a lower standard of living. Let us hope that the utility company is not contributing largely to perpetuating that sentiment.

Beyond even the increased cost to individual homeowners, an even larger cost factor will be the water usage by the associations to maintain clubhouses, golf course and green belts. The calculated proposed (estimated) yearly increase for the Cottonwood/Palo Verde areas (3,809 units) goes from \$45.04 per unit/lot to \$87.58 per unit/lot. This is an annual increase of \$42.54 per unit/lot, or a 94.44% increase. Coupled with the individual homeowners increase, this will amount to a minimum of between \$139.00 and \$163.00 per home unit --- depending on how much the association board of control raises the yearly association dues. It should be noted here that the figures quoted are for only one area of Sun Lakes. They do not speak to the costs associated with the original Phase I area, or the Oakwood/Ironwood portions as they now exist.

It is our hopes that your will temper this proposed increase to stay within more reasonable limits. Personally, we have seen nothing to date that would warrant this increase by Pima Utility Co.

Dear Arizona Commissioners:

I am writing to express my outrage at Pima Utility's proposed exorbitantly high increase in rates. If passed, the rates will no doubt become the sole responsibility of each and every homeowner within our community. Our maintenance fees are already high and are some of the highest in the state. If the proposal is passed, the impact on the homeowners would be detrimental.

We are an "active adult" community. Although some of homeowners are retired, many are not. Many of us have already lost our jobs and are barely hanging on to our homes. With so many people unemployed, employers do not have to hire anyone over 40 so, future employment for many of us looks dim. We have essentially become, a new class of unemployed - the older unemployed who nobody wants anymore. As well, many homeowners lost a substantial amount of their retirement when the economy bombed and we do not have a lifetime of future employment to make it up. Many of us simply are not in a position to be able to handle such high increases. Those who are retired are on fixed incomes and huge increases, such as the one proposed, do not fit into many retirement equations.

In addition, the homeowners only recently finished paying off our Clubhouse renovation cost, which was, I believe, in excess of \$4,000 per homeowner.

Any increase by Pima Utility Co. should not only be substantiated by their own increase in costs and aligned with those costs but, should not be higher than the current inflation rate. The state of economy and, any and all such other matters that might pertain to justifying such an increase, should also be taken into account including, what might be considered a "reasonable" increase

The increase that Pima Utility proposed would create a hardship for many, if not most, of us. As a result, I am voicing my objection and asking you to do what you can to deny, thwart, refute and reject such a proposal, as unreasonable, unnecessarily exorbitant and, a hardship for the homeowners of this community.

I am a customer of the PIMA Utility Company and am a resident in Sun Lakes, Arizona and I object to PIMA's unconscionable rate increase request.

I understand the 29.2% increase on water and 22.2% increase for handling waste water will increase my bill by approx. \$5.06 per month on the sewer use and \$3.83 per month on the water use or a total of \$8.89 per month- \$106.68 annually. I cannot imagine any possible justification and I request you refuse the request outright. Send the requesters back to do their homework and have them determine what cost cutting measures they can implement to meet their required margins.

Additionally, since I am a resident of Cottonwood Palo Verde at Sun Lakes, our Homeowners Association has advised me that the irrigation water cost for our common areas would increase 94.44%- from \$171,560 in 2011 to \$333,581 in 2012 if you were to grant their request.
