	June 7, 11, 12, 13



1 Direct Testimony by BHOA. Though the Resort and Staff are not joining in offering the
2 Stipulation of Facts, they do not object to the stipulated facts being admitted in lieu of
3 Direct Testimony from BHOA.

4 The Parties expect that the hearing in this matter would require no more than 3
5 days. In recognition of the difficulties in scheduling three consecutive days for hearing,
6 the Parties request that the Commission schedule the soonest possible dates for hearing,
7 regardless of whether such dates are consecutive.






