
MOTION FOR ORDER SETTING
HEARING

Qwest Corporation d/b/a CenturyLink-QC ("CenturyLink") moves for an order setting a hearing for oral argument. CenturyLink respectfully requests a hearing date in the month of May, 2012.

1 By Procedural Order entered on August 24, 2011, the oral argument hearing set for
2 August 31, 2011 was vacated, upon the joint motion of the parties. At that time, the parties
3 sought a continuance in order to give them an opportunity to continue settlement discussions.
4 CenturyLink regrets to report that the intervening months have not resulted in resolution. In
5 CenturyLink's view, it is necessary to define the time period for settlement discussions by setting
6 a hearing date. CenturyLink believes that a hearing date in May, 2012, will give the parties
7 sufficient time to strike a resolution if a resolution can be reached, and submits that the May
8 timeframe is a reasonable time period for the hearing if consensual resolution cannot be reached.
