PROCEDURAL ORDER

BY THE COMMISSION:

On July 14, 1997, Metro Connection dba TransAmerican Telephone, Inc. ("TransAmerican") filed with the Arizona Corporation Commission ("Commission") an application for approval to provide resold local exchange telecommunications services within Arizona.

On April 1, 1999, in Decision No. 61604, the Commission granted TransAmerican a Certificate of Convenience and Necessity ("CC&N") to provide resold local exchange telecommunication services.

On February 22, 2001, a Memo of Non-Compliance from the Compliance and Enforcement Section of the Commission's Utilities Division was entered into the Docket.

On April 30, 2001, TransAmerican filed a letter indicating that it was out of business.

On January 29, 2009, in Decision No. 70705, the Commission revoked TransAmerican's CC&N for failure to file its 2006 Utilities Division Annual Report.

On March 13, 2012, the Commission's Utilities Division filed a memorandum recommending that the Docket be administratively closed.
